It had your reservation in Helaman Halls for the school year 1966-7. XXXXX it says:

If you accept this reservation, please sign the original housing agreement and return to this office on or prior to August 3, 1966.

To finalize the reservation, it says, the first payment must be made on or prior to August 3, 1966. And it says to send in payment as scheduled in the houseing agreement. It notes that we previously paid the #10.00 application fee.

It says that the Room or apartment number and Roommate assignments will be mailed as soon as possible after July. and that you will also receive further information: (1) a definite room or apartment number (2) the time you should arrive (3) what you should bring.

It says Roommate Requests will be honored provided the requested roommate has submitted an application and advance payment by the time assignments are made and provided both parties have priority for assignment & to the same unit. After July 1, it becomes exceedingly & difficult to promise roommates for a specific room or apartment. It says, "Do not write askfing for this information for you will receive it prior to Sept. 1.
